2. **Second Payment:** Submit the second payment fee of **\$5112.75** (75%) on or before **August 4, 2026**. An \$800 late fee will be imposed beginning August 5, 2026.
3. **Final Payment:** Submit final payment fee of **\$1704.25** (24%) on or before **September 14, 2026**. An \$800 late fee will be imposed beginning September 15, 2026. We reserve the right to cancel league entry if the final payment is unduly delayed.
